Scholarship

Nanjing Audit University awards excellent international students with scholarships. The scholarships are categorized into full scholarship and partial scholarships. Full scholarships cover tuition, accommodation, medical insurance, and stipend. Partial scholarships cover full tuition or partial tuition only.

All scholarship winners are annually evaluated. Those passing the annual evaluation are eligible for scholarship support the next year.
